

## The Revd Roger Powell writes...

Easter is very early this year and so therefore is lent. Ash Wednesday (the first day of lent) is on the 6<sup>th</sup> February and you can find more details about the services on that day elsewhere in this issue.

During the days of lent we are given the opportunity to deepen and strengthen our relationship with God; to commit ourselves afresh to proclaiming God's presence and love, as we go about our daily lives. ## Parish Council Meeting

.At the Parish Council Meeting held on January 10<sup>th</sup> it was decided to increase the annual precept for the first time in many years, from £1500 to £5000. This will mean an increased cost to Band D properties (the base marker for Council Tax) of approximately £7.26 for the year. It is anticipated that the current year expenditure will exceed the precept by £2500 and, although this will be met by reserves, this level of expenditure to meet increased costs is expected to continue

Tim Frost and Paul Scott gave an update on the Parish website. Work is underway to ensure ease of use and the regular updating of the site. The chairman proposed five categories for the Parish Council section: Councillors – contact details and photographs; a summary of the responsibilities of Parish, District and County Councils; current and past minutes: Planning linked to the Kennet District Council site; Parish Council events and a separate area of the website for a calendar of all village events. The Parish Council agreed to fund costs of up to £150 during this development stage.

Cllr Willis reported on the plans to improve traffic flow at the school. The School has submitted an application to the County for funding of road safety and traffic flow improvement measures. This includes - moving the school warning sign (village hall side) up the road to provide earlier notice to drivers and to extend the pavement outside the school to improve pedestrian access and safety.

Cllr Smith reported that the speed monitoring device recently installed has shown that there are speeding issues that need to be addressed. Wiltshire and Swindon Safety Camera Partnership has suggested that they could arrange temporary erection of vehicle activated signs and pass information to the Police to enforce the limit. The Council agreed to consider the options. The problem of illegally parked cars at the t-junction of the Main Street and Old Marlborough road was also raised. It was agreed to draft a letter alerting residents to the danger that this causes and create a parking strategy for the area at the next meeting.

Parish Council elections will be delayed until 2013 against the Councillors' preferred option to have an election in 2009. WCC will be providing a strategy document to enable Parish Councils to decide which services they wish to control. Councillors expressed the need to ensure that funds are allocated with the services.

Amongst Planning applications it was reported that the erection of an office block at Old Chase Road, renewal of a first floor extension at Carlisle House, a two storey extension at Teach Nua and refurbishment at Cotswold House have all been approved by KDC. A revised plan for a single storey extension at Amberley will be considered.

Other matters raised included an update on the foul water investigation in the field at Whitefields Farm. The Environment Agency is still to determine the source. The Clerk will investigate the possibility of having plastic bottle and cardboard recycling bins at the Sonia Wright Nursery site and will also request Wiltshire County Council to replace the railings on the path to the main road bus stop.

Please be vigilant regarding the use of this facility and report any suspicious dumping activity to the Parish Clerk or any Councillor.
